

Macarthur Square x Macarthur FC 'Be our Next Football Star' Terms and Conditions

Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Ltd of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is 02 4626 1466.
2. Only residents of Australia aged between 8 years and 13 years of age inclusive (**Participant**) are eligible for the Competition. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the Competition, evidenced by the parent or guardian submitting the video.
3. The following person(s) are ineligible to enter the Competition:
 1. employees of:
 2. the Promoter; and
 3. the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies and contractors; or
 4. members of the Immediate Families of the employees referred to at paragraph 3.

Immediate family means any of: a spouse or domestic partner, ex-spouse or ex-domestic partner, de-facto spouse or ex-de-facto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.
5. The Competition commences at 12:00am on Thursday 15 October and closes at 11:59pm on Sunday 25 October (**Competition Period**). The Promoter may extend the Completion Period at its sole discretion (**Extended Competition Period**). Details of any Extended Competition Period will be posted on www.macarthursquare.com.au. References in these terms and conditions to the Competition Period include any Extended Competition Period, where applicable.
6. The prize includes the following (**Prize**):
 - Feature within the Macarthur Square and Macarthur Football Club (**Macarthur FC**) season launch video to be shown across the Macarthur Square and Macarthur Football Club social channels, website and in centre at Macarthur Square from November 2020. Those selected will need to be available on Friday 30 October for filming at Macarthur Square.
 - A behind the scenes experience at one (1) Macarthur FC A-League training session on an agreed date and time during the 2020/21 A-League season commencing in December 2020.
 - A one (1) hour one on one training session with Macarthur FC on an agreed date and time during the 2020/21 A-League season commencing in December 2020.
 - Macarthur FC merchandise pack to the value of \$100 – to be collected from the Macarthur FC Experience Store, opening in December 2020.
 - A family dining experience at Macarthur Square, valued at \$200 (per winner – 2 in total, total value \$400). The dining experience will be issued as a Macarthur Square Gift Card, valid for three years from the date of issue.
7. To enter, the Participant or Participant's parent or guardian must upload a video entry to their own personal Facebook or Instagram page, tagging both Macarthur Square and Macarthur FC in the post and including the hashtag #mfcstars. The profile should be set to Public to ensure visibility of entry. The video should be maximum 60 seconds in length, featuring the Participant showing their best football skills and stating why they are the next upcoming football star.
8. For the Participant to be eligible to compete in the Competition, the Participant must enter the Competition:
 1. within the Competition Period;
 2. in the strict manner specified within the Terms and Conditions for the Competition; and
 3. by the method specified on the Macarthur Square and Macarthur FC websites.

5. The best two entries will win a Prize.
6. The Prize is not redeemable for cash.
7. The Prize is personal to the winner. It cannot be transferred, exchanged or otherwise dealt with.
8. The Promoter assumes no responsibility for lost, misplaced, destroyed or stolen Prizes once they are claimed.

9. The entries will be judged by a judging committee between 12:00am and 5:30pm on Monday 26 October at Macarthur Square. Winners will be published on the Macarthur Square and Macarthur FC Facebook Pages at 5pm on Tuesday 27 October.
10. This is a game of skill and chance plays no part in determining the winner. Each entry will be individually judged based on artistic merit.
11. The judge's decision is final and no correspondence will be entered into.
12. By entering into the Competition the Participant (or its parent and guardian) is/are deemed to have accepted these terms and conditions.
13. The Promoter reserves the right to request winners to provide proof of age and identity and eligibility to participate in the Competition. In the event that a winner cannot provide suitable proof, the winner will forfeit the Prize in whole and no substitute will be offered.
14. Macarthur FC and Macarthur Square physical prize elements must be collected from the Macarthur FC Experience Store or the Guest Services Desk at Macarthur Square at an agreed time in December 2020 upon store opening. Prizes must be collected by Wednesday 31 March 2021. The winner's parent or guardian must accompany the winner in order to collect the Prize and the Prize will be awarded to the winner's parent or guardian. For the experience elements of the Prize, these will be at a mutually agreed date and time within the 2020/21 A-League season. Parents or an appropriate guardian must accompany the children for these elements of the Prize.

Nothing in these terms and conditions is intended to exclude, restrict or modify rights which the Participant may have under any law (including the Australian Consumer Law) which may not be excluded, restricted or modified by agreement ('Your Consumer Rights'). Any condition or warranty which would be implied by law into these terms and conditions is excluded.
