

# Macarthur Square Voucher Book 2022

## Terms and Conditions including the Privacy Statement

### Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Limited ACN 002 894 153
2. of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo
3. Avenue, Barangaroo, NSW, Sydney 2000 (Lendlease). Contact number is 02 9236 6111. Only residents of Australia aged 14 years of age or older (**Participant**) are eligible for the Competition. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the Competition, evidenced by the parent or guardian signing the entry form.
4. The following person(s) are ineligible to enter the Competition:
  - (a) employees of:

  - (a) Purchase while stocks are available

  - (c) in the strict manner specified on the entry form for the terms and conditions;
  - (d) by the method specified on the purchasing form on Eventbrite; and
