

Macarthur Square Spring 2024 GWP - Terms and Conditions

Terms and Conditions

1. The Promoter is Macarthur Square Shopping Centre of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is (02) 4626 1466.
2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the promotion. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the promotion, evidenced by the parent or guardian completing the entry form.
3. The following person(s) are ineligible to enter the Competition:
 1. employees of:
 - The Promoter
 2. the Promoter's related bodies corporate (as that expression is defined in the Corporations Act 2001 (Cth), and associated agencies, companies and contractors; or
 3. members of the Immediate Families of the employees referred to at paragraph below.
