

## Terms and Conditions including the Privacy Statement

### Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Limited ACM 002 894 153 of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is 02 9236 6111. Permit Number LTPS/20/41917, NSW.
2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the Competition.
